

Privacy Policy

1. Introduction

2. Data Collection and Use

To remove persistent cookies, contact us.

10. Storage and Retention of Personal Information

We take appropriate measures to securely store personal data and retain it as long as necessary to maintain our business relationship or as required by law. When no longer needed, we anonymize or securely destroy your data, although certain records may be

retained for regulatory purposes. Telephone and electronic records are held for five years after the end of our business relationship, or longer if required by law.

11. Your Rights Regarding Personal Information

You have rights regarding your personal data, including:

- **Information and Access:** Request a copy of your personal data.
- **Rectification:** Update inaccurate or incomplete data.
- **Erasure:** Request deletion under specific circumstances.
- **Processing Restrictions:** Limit how we process your data in certain situations.
- **Data Portability:** Obtain a copy of your personal data in a structured format.
- **Objection:** Request to stop processing under certain grounds.
- **Automated Decision-Making and Profiling:** Opt out of decisions made solely by automated means if they significantly affect you.
